

LEP CHAIRS MEETING

Tuesday 29th May 2018

Summary Notes and Actions

1. Welcome and Introductions

1.1. Christine Gaskell, as meeting chair, welcomed everyone to the meeting. (This meeting is open to all LEP Chairs and wider participation is always welcomed and encouraged.)

2. LEP Review

2.1. Before officials from the Ministry of Housing, Communities & Local Government (MHCLG) joined the meeting, LEP Chairs discussed areas they would like to discuss with officials, including an understanding of the timescale for the LEP Review to report.

3. LEP Review - views from MHCLG

Simon Ridley, Joe Manning and Jonny Wright from MHCLG joined the meeting.

- 3.1. Officials provided an update on the LEP Review in the context of the Industrial Strategy and the design of future local growth funding.
- 3.2. Government is reviewing the roles and responsibilities of LEPs the Review will set out a more clearly defined set of activities and objectives.
- 3.3. The LEP Review is considering:
 - 3.3.1. leadership and accountability;
 - 3.3.2. institutional form;
 - 3.3.3. performance and transparency;
 - 3.3.4. geography, including reviewing overlapping geographies;
 - 3.3.5. the LEP role in Mayoral Combined Authority areas.
- 3.4. Officials noted the LEP workshop planned for 17th July as a good opportunity for engagement.
- 3.5. There was a discussion about the role of the LEP Network, and LEPs as a sector.
- 3.6. Government is committed to LEPs, the partnership of private and public sectors, as well as leadership in economic strategy, as well as sub-national approaches of Northern Powerhouse, Midlands Engine, Ox-MK-Cambs Corridor etc.
- 3.7. Simon supported an open dialogue between the CLoG team and LEP Chairs to help shape the LEP Network model, including responding to expectations in the LEP Review.
- 3.8. There was a short discussion on the Council of LEP Chairs. This is a positive opportunity for LEP Chairs as local business leaders providing macro messages on the economy to inform and positive conversation with the PM. CLoG officials will work with the LEP Network to support preparations.
- 3.9. On Whitehall Senior Sponsors, this is an opportunity to deepen a connection with Whitehall and local places. Simon is convening a Senior Sponsors group meeting.

ACTION: Warren Ralls will pick up the above with CLoG officials.

Simon Ridley, Joe Manning and Jonny Wright from MHCLG left the meeting.

4. LEP Chair Reflections

- 4.1. LEP Chairs welcomed the update from Simon Ridley.
- 4.2. It was agreed that the LEP Network proceed with plans for Tuesday 17th July.
- 4.3. Ministers leading the LEP Review should be invited (Jake Berry MP, Lord Henley, Robert Jenrick MP) and the Secretaries of State Rt Hon Greg Clark MP and Rt Hon James Brokenshire MP.
- 4.4. Warren also suggested inviting Jeremy Heywood, Cabinet Secretary and Head of the Civil Service.
- 4.5. The meeting can also discuss the role of the LEP Network.

5. Council of LEP Chairs

- 5.1. LEP Chairs agreed that a co-ordinated communication will help to land key messages, and maximize the use of time available.
- 5.2. LEP Chairs agreed there should be a managed process where nominated LEP Chairs spoke first delivering the key messages, and then other Chairs come in. There would need to be a pre-briefing for those Chairs speaking first.
- 5.3. LEP Chairs suggested that Warren issued a template to LEP Chairs to gather their input on key messages. The information received can then be compiled into a briefing note for No.10. If there wasn't sufficient time for every point to be aired in the meeting, the briefing note would help to convey all the points.
- 5.4. Following the meeting, Warren Ralls spoke with CLoG officials. More information is expected to be sent to LEP Chairs shortly.
- 5.5. Warren is awaiting further guidance on how the discussion will run, and the themes that will be discussed, and how LEP Chairs will be asked to contribute their views.
- 5.6. Warren will gather more info, to guide the template to be issued to LEP Chairs.

6. Role of the LEP Network

- 6.1. LEP Chairs agreed the proposed 'Ways of Working' where a 'Strategy Group' of LEP Chairs (covering a representative cross section of LEPs) will meet regularly on areas of policy and strategy; and that the three LEP Chairs who are Company Directors will be responsible for the LEP Network Limited 'company business'.
- 6.2. Assuming some time on the 17th July will be spent on the role of the LEP Network, Warren will seek volunteers from LEP Chairs to meet as a 'working group' to discuss further. It was agreed to use some time after the Council of LEP Chairs in mid-June.

7. LEP Network Operations

- 7.1. LEP Chairs noted the operations report, and agreed the proposed LEP Network budget for 2018/19.
- 7.2. Warren will pick up the signing off of the 2017/18 Audited Accounts with the three LEP Chair Company Directors.
- 7.3. Ann Limb raised the proposed meeting with Rt Hon Anne Milton MP (DfE, Skills Minister). Warren is liaising with her office on dates, and suggested Monday 16th July the evening before the LEP Review workshop.
- 7.4. Christine Gaskell raised that the LEP Network is working on an event with women business leaders to help LEP attract more women to LEP Boards. This is welcomed by MHCLG. Ann Limb suggested she may have an interested sponsor for the event. LEP Chairs agreed that after this event, there could be more discussions on other diversity areas, e.g. ethnicity.
